More autonomy, new programmes for IITs

NEW DELHI: The Indian Institutes of Technology may soon adopt a blueprint for reforms aimed at pushing IITs up the global rankings. Under the new blueprint, the institutes will increasingly fund themselves and also gain greater autonomy from the government.

Human resource development minister Kapil Sibal has called a crucial meeting of the IITs to discuss three reform plans and a new set of academic programmes the institutes want to introduce. The IIT Council will meet on January 21 to shore up plans in governance and administration, promotion of students from one semester to the next and examination reforms, top government sources told HT.

The agenda for the meeting also includes plans to introduce programmes in cyber security, and ratification of extensions granted to the directors of IIT Madras and Delhi. "We will take up the reform plans at the meeting," HRD minister Kapil Sibal told HT. IIT Bombay chairman Anil Kakodkar, head of a panel set up by Sibal to prepare the blueprint, is expected to make a presentation on the panel's report at the meeting.

The panel is expected to recommend a new financial model to allow the IITs to generate their own income and depend less on the government. In return, the IITs will receive greater autonomy.

IIT Kanpur Director Sanjay Dhande is expected to deliver a presentation on a proposal to uniformalise the criteria for promoting students from one semester to another across IITs - a demand frequently raised by students. Dhande was in 2010 appointed head of a panel by Sibal to prepare a strategy to end the system of different IITs employing varying performance criteria for promoting students. A panel under science and technology secretary T Ramasami is working on examination reforms.

"None of the three panels have submitted their final reports yet, but are expected to present at least a template," a source said. The meeting is also expected to clear a proposal to set up a permanent secretariat for the IIT Council.

London: Blood group 'O' protects people against heart attacks, say researchers.

A new study, published in The Lancet journal, has revealed that the same gene which creates the enzyme that causes people to be blood group 'O' gives them some protection against heart attacks.

The study was carried out by an international team led by researchers from Cardiovascular Institute at Pennsylvania University in the US. For their study, the researchers compared almost 6,000 people who had suffered a heart attack with 7,400 people who had a type of coronary heart dis-ease, but had not had a heart attack. They described the association as "notable, in view of decades of work suggesting a relation between ABO bloodgroups and both thrombosis and coronary heart disease".

However, the study did not look to quantify how much extra protection being blood group 'O' might give someone from having a heart attack.

"Certain genes predispose to heart artery plaque buildup, whereas different genes lead to heart attack when you already have plaque build-up,' said study author Muredach Reilly, an associate professor of medicine at the Cardiovascular Institute of the University of Pennsylvania.

One of the more heartprotective genes also helps direct people to have type O blood, the team reported. The study suggests the multifaceted relationship between genetics and cardiovascular health, Reilly said. "Not all genes for heart disease are equal and therefore have to be used differently in new treatments for heart disease and when assessing risk of heart disease," he said.

But one expert cautioned while blood type O may offer some protection from heart attack in people with coronary artery disease, that doesn't mean that your blood type alone will spare you from cardiovascular trouble. AGENCIES

Washington: A Stanford researcher has started developing video games using biotechnology.

Ingmar Riedel-Kruse has begun developing "biotic games" involving paramecia and other living organisms.

In his video games, a player's actions influence the behaviour of living microorganisms in real time – while the game is being played.

"We hope that by playing games involving biology of a scale too small to see with the naked eye, people will realize how amazing these processes are and they'll get curious and want to know more," said Riedel-Kruse.

"The applications we can envision so far are on the one hand educational, for people to learn about biology, but we are also thinking perhaps we could have people running real experiments as they play these games," he added.

Riedel-Kruse and his colleagues tried creating some classic games like PacMan, which was renamed as PACmecium, Biotic Pinball POND PONG and Ciliaball.

The basis of the games is paramecia– the single-celled organisms.

A camera sends live images to a video screen, with the "game board" superimposed on the image of the

paramecia. A microprocessor tracks the movements of the paramecia and keeps score.

We are talking about mi crobiology with these games very primitive life forms. We do not use any higher-level or ganisms," he said.

"Since multiple test play ers raised the question of exactly where one should draw this line, these games could be a good tool to stimulate dis cussions in schools on bioeth ical issues."

decade, we could focus on developing world-class beaches, clean waterfronts, marinas, cafes and restaurants. We could develop world-class water sports facilities and theme parks as well.




