Alumni backlash for Sibal's IIT plan

The announcement on the changed format of the Joint Entrance Examination (JEE) has provoked a back-lash from the IIT fraternity.

Less than a week after the announcement was made by HRD minister Kapil Sibal, faculty and alumn members of different IITs have started working on ways to register their resentment against the change.

their resentment against the change. In the first signs of an organised protest, the alumni members of IIT-Delhi, are preparing to move court against the decision. In a meeting held on Friday morning, the alumni association also decided to have a point-by-point rebuttal to Sibal's 'One Nation One Test' proposal prepared by the IIT faculty and communicate their objections to the Prime Minister through a memorandum.

On May 28, Sibal, after chairing a joint meeting of the IIT and NIT Council, had announced that from next year the Joint Entrance Examination or JEE will be valid for all centrally funded technical institutions (CFTIs) such as the IIITS, NITC and USEER, LIFE will be tions (CFTIs) such as the IIITs, NITs and IISERs. JEE will be conducted in two parts — main test and an advance test — and have multiple-choice objective-type of questions.

he Human Resources Development Ministry has announced its latest regulations for admissions to engineering colleges. Mr Ashok Kumar, the police officer activist who trained 33 rural youths and managed to get 30 of them through the Joint Entrance Examination JEEJ for the

This is 330th in the Vision 2020 series. The last article appeared on May 19.

Indian Institutes of Technology (IITs), has been so incensed that he has organised a big demonstration in Patna against the decision. Some alumni may even go to court.

The new regulations have tackled reasonably well two of the three objectives. One, it gives due importance to high-school examination.

Two, it reduces the burden on the students by having one common examination for all Central Government institutions. However, it is not likely to do much for the third objective of curbing the influence of coaching institutions.

Even in the first two cases, there are issues. For instance, many years ago, the IITs admitted the top 10 from each school beard directly without any entrance test:

That was a disaster, the system had to be stopped because influential persons got false certificates for their wards.

What guarantee is there that something similar will not happen in the certificate for percentile scores? However, corruption now may be less because the candidates have to take the entrance test, too.

The new norms for engineering entrance exams cannot address the rich-poor, or rural-urban divide. There are better ways of dealing with these problems.



Nowhere In the world are admissions carried out purely through a mechanical test.

A single test is a good idea, but it has its own problems. What will happen if a paper is leaked in some obscure corner of the country? Will or should the tests in thousands of centres round the country te scrapped and re-held? In any case, how will the Government keep the question papers secret everywhere without fail? These are real issues to which the Government seems to have given little thought.

I do not think anyone will lay a claim that the influence of coaching centres will diminish. At present, coaching costs are heavier than the four-year tuition chargesin the IITs. Yet, they will probably increase to coach students for the plus-two examinations, too. Hence, only the well-to-do will get that benefit. Then, will not the rich-poor divide increase? Mr Kumar is vorried that the new programme will impose a heavier burden on rural children. As it is, rural schools are pocrly off; they are worse than the schools in the cities and far worse off than the good

ones. Frankly, the Government has not thought of the rural-urban divide at all. Our present-day politicians are enamoured of quotas. Who knows, we will have a new quota for rural schools, too.

DEFICIENT FILTER

The biggest question of all is whether the new system will identify and admit students of the best calibre. It probably will not. As matters stand, admission to the IITs is a gamble — a chance of one in a hundred or so. In comparison, great universities such as Harvard and Stanford get only 10 applications for each student admitted. So long as the application-admission ratio remains as high as it is in India, no programme will be truly rational.

Further, nowhere in the world are admissions made purely through a mechanical test. For instance, SAT scores are used as a guide by American universities; they do not determine admissions entirely. Our country is so obsessed with objectiv-

ity that it forgets that we produced better scientists and engineers before Independence, too, when there were no entrance tests at all and teachers took who they liked. Unfortunately, the present government has no such faith.

WHY WE LAG

Nobody has asked the crucial question: why have MIT, Stanford, Oxford and all the great universities of the West done better, and are still doing better than our own institutions and do so in spite of admitting less-qualified rich students? The basic reason: those universities have the autonomy to admit whoever they like, including children of the very rich; our institutions have no autonomy and are shackled by the State.

Years ago, the IITs were concerned about the varying standards of high-school boards; they were worried by political interference. That is how they devised the JEE. Unfortunately, they forgot they were giving up a precious privilege — the autonomy to select their own students. Even now, according to the statutes, only the individual IITs can decide on admission policy—not the government. The Minister, being an able lawyer, may be able to get round, if, for instance, as is possible, IIT Kanpur refuses to accept his rules. But let us remember that the IIT statutes are good; that is why they have performed better than the universities have.

TWO SOLUTIONS

What is the ideal that will ensure the autonomy of not only the IITs but also of all other institutions, and at the same time minimise rural urban and rich-poor divides? I suggest that each district gets a quota — for short-listing the applicants — that depends on its population; the districts will conduct independent tests to fulfil their quota. That way the rural-urban divide will be minimised.

Alternatively, each IIT may shortlist four or five times the number of students it is entitled to admit after they pass class 10 and provide the selected students scholarships to study in the best schools for the next two years. That way, the influence of coaching centres too will diminish, reducing further the rich-poor divide.

Only through interviews will the teachers know whether the applicant is a 'muggo,' or whether he understands the subject. Undoubtedly, the faculty will be under enormous pressure from politically powerful persons to admit their nominees. That may be resolved in one of the two ways: IITs admit some of them, the way Western universities do, but on payment of very high fees, or stick to their guns.

I think the first proposition is better. If a rich or influential person's ward canbe admitted to Harvard, no disaster will ensue if they are admitted to an IIT.

IIT alumni oppose new entrance exam

NEW DELHI: The alumni association of Indian Institute of Technology, Delhi on Friday opposed the recent decision to change the format of the entrance exam to get into ITT

Human Resource Development (HRD) Minister Kapil Sibal on Monday had announced plan to conduct a common engineering entrance test from 2013 for engineering and science institutions funded by the Central government.

In a meeting, members of the alumni association, All India IIT faculty federation, PanI-IT and IIT alumni of Kharagpur stated that the complete control of the IIT examination should remain with IIT, like the existing pattern.

Members of the faculty federation have recently sent a letter to Prime Minister Manmohan Singh expressing their opposition to the plan.

Sibal, in response to the growing opposition from the IIT's to the common entrance test, stated that the IIT council along with the council of National Institute of Technology

(NIT) and Indian Institutes of Information Technology (IIIT) had unanimously taken the decision.

"Senates of IITs should have the final say on the new patternand can not be overridden by IIT council," said a member. All India IIT Faculty Federation secretary A K Mittal stated that they would send their rebuttal to the proposal on June 2. Mittal and Sanjiv Sanghi, president faculty forum, will communicate with various IIT senates and arrange formal rejection of the May 28 proposal of the HRD Ministry.

"We have decided that the IIT alumni will form a lobby group to meet the prime minister and submit a memoran-

dum to apprise him with the objections in three-four days. PILs will be filed in various High Courts within a week," said the member. It was unantmously decided to demand a status quo till 2014.

The exam will be known as ISEET, the first common entrance test for engineering colleges of the country to enroll students in bachelor programmes. The ministry is all set to do away with the two well-known engineering exams AIEEE and IIT-JEE from next year. The ISEET main and advance exam will carry 60 per cent weightage, and 40 per cent will be given to Class XII board exam scores.

IIT-K faculty, alumni boycott 'autocratic' Sibal

5 professors to skip convocation; former students plan to meet PM to protest

Within a week of HRD Minister Kapil Sibal claiming that the decision to hold 'One-nation-one test' was endorsed by all the IITs, the faculty association of the prestigious IIT-Kanpur has decided to boycott the convocation scheduled on Saturday.

Simultaneously, the Kanpur IIT alumni association on Friday condemned the 'autocratic' decision of the HRD Ministry and sought an appointment with Prime Minister Manmohan Singh to register their protest against the alleged conspiracy to bring investments from foreign universities to open technical insti-tutes here. They also want to inform the Prime Minister that the Kanpur IIT senate was kept in dark about the Joint Entrance Examination (JEE) reform plan.

The Executive committee of IIT Kanpur Faculty Federation in an official communication to the General Body Meeting of the IIT Alumni on Friday conveyed that "as a strong symbolic



protest against the sidelining of the IIT-Kanpur Senate in the ongoing process of JEE reforms, the members of the senate and the faculty in general would abstain from the convocation function, including the academic procession".

Yes, the faculty members have decided to lodge their protest by not participating in the convocation. As of now all of them have agreed, but let us wait to see the turnout of solidarity till tomorrow," a professor at IIT Kanpur said over phone requesting anonymity.

At least five professors have gone out of town to keep away from the convocation on Saturday. Yes, I will not be there as am out of town," said another professor when contacted by The Pioneer.

While this is expected to send a strong message, it will not hinder the process of awarding degrees to the graduating students in any material manner," said Prof AK Mittal, Secretary, All India IIT Faculty Federation.

A special meeting of IIT Kanpur Senate has been called on Saturday to discuss the sidelining of IIT-K senate in JEE reforms by the Ministry and legal repercussions.

The IIT Alumni association on Friday formed a lobby group to seek appointment from the Prime Minister at the earliest and submit a memorandum to apprise him with the objections before the Central Advisory Board on Education (CABE) deliberates over the issue. "There is a larger conspiracy in the matter. The Government is trying to dilute the present IITs and to facilitate private players from India and abroad. They are also mulling to bring investments from foreign universities to open technical institutes here. What is wrong in the present IITs," Somnath Bharti, president, IIT-Delhi Alumni Association (IIT-DAA) told The Pioneer.

Claiming that the IIT-Kanpur Senate was kept in dark, the GBM alleged that Sibal did not keep his promise made to different stakeholders that he will not go ahead without consensus. "Five out of seven senates have given their dissents in writing but MHRD still went ahead. The IIT Council is an advisory body qua admission process and senates enjoy the conclusive authority qua admission process as per the IIT Act," said Mittal.

The meeting held at Alumni Association Office of IIT Delhi was attended by Somnath Bharti, president, Pravin Purang, Secretary, IIT-DAA, Prof Sanjeev Sanghi, president, Faculty Forum, Prof AK Mittal, Secretary, All India IIT Faculty Federation, Vanita Srivastava, Alumnus, IIT Kanpur, Y P S Suri,

President, IIT Kharagpur amongst others.

"While full control of the examination should remain with IITs as it is in present, the school marks should act as a cut off and not given any weightage. In the given new format stress on school board, JEE (main) and JEE (advance) will only increase the pressure on students rather than taking that off and will further propel the coaching industry by manifolds. Our demand is that Senates of IITs should have the final say on the new pattern and can't be overridden by IIT council," Bharti added. The IIT alumni association is also looking into legal options to put in abeyance the One Nation One Test concept. IIT Alumni will arrange PILs to be filed in various High Courts within a week. It was felt that it should be tried to get the same heard before June 5, the day a meeting of CABE committee of MHRD is scheduled.

Common test: IIT faculty write to PM

New Delhi: In IIT Kanpur, there is a deep sense of dissatisfaction that the HRD ministry had not heeded the faculty's concerns before announcing the decision on a common engineering test for central engineering institutions. Therefore, there is a plan to boycott the convocation ceremony on Saturday. A senior faculty member from IIT Kanpur said. "Although all faculty members are upset with the decision, some will attend the convocation because it's an important occasion for the students."

All India IIT Faculty Federation secretary A K Mittal said, "People across IITs are concerned and agitated at the ministry's decision. We have written to the PM opposing the decision and will seek time from him."

The main points of differences between the faculty members and the ministry include, the weightage given to class XII board exams for shortlisting candidates and the lack of complete control over the IIT exam. There are 15 IITs with about 10,000 seats in the country. At the root of the debate is the elite status of these tech institutes, and clubbing them with IIITs and NIITs is seen as making centres of excellence come down to the level of ordinariness.

HRD ministry sources said that efforts were being to ensure that the matter does not go to the courts. A senior official said, "The ministry has over a period of two years held lengthy consultations and tried to accommodate all the concerns raised by the various stakeholders." Ministry sources said that the IITs are geared for conducting exams for 5-6 lakh students but the numbers would increase to 20 lakh with the common test. "We have even said that IITs will be able to direct the agency that conducts the test." the source said, pointing out that the concerns being raised had been dealt with through several rounds of consultations.

NEW DELHI: Tempers are running high. A direct confrontation between IITs and the Centre has shaped on the changed pattern of IIT-JEE As a first step to register protest, a PIL may be filed in a HC on Monday against the government's decision.

Representatives of the Alumni Association and the All India IIT Faculty Federation, which met on Friday devised a three-pronged strategy to register protest.

They have decided to lead a delegation to the PM and submit a memorandum raising their concern over the autonomy of the IITs. It was also decided to identify persons who could file petitions in different high courts against the government's decision in the next few days. The All India ITT Faculty Federation will prepare a rebuttal of the government's decision shortly.

"We will lead a delegation to Prime Minister in the next few days and submit a memorandum. We are also looking for people who could file PIL in different high courts," Somnath Bharti, President Delhi IIT Alumni Association and Supreme Court advocate said.

The IIT senates are also in a confrontation mood. Raising strong objection against the government's decision, IIT-K Faculty has described the new exam as counterproductive, unilateral, and arbitrary.

There are speculations that a motion could be raised against the Chairman of the IIT-Kanpur Senate who is also the director of the institute for 'misguiding' the Senate in the whole process. There are 210 senate members. There was also a suggestion that IIT Kanpur should press for a separate exam if the government does not roll back its decision. Some faculty and senate members may also boycott the IIT-Kanpur convocation on Saturday to register their protest.

CAT: IIT alumni demands status quo on implementation

NEW DELHI: Strongly opposing the new format for admission to IITs and other central institutes from 2013, the IIT alumni association on Friday decided to move court and demanded a status quo on its implementation till 2014.

At a meeting here, the association also decided to form a lobby group and meet Prime Minister Manmohan Singh objecting the move.

The association contended that HRD Minister Kapil Sibal did not keep his promise made to different stakeholders of not going ahead with the new format if there is even one dissent from the IIT senates.

The association also dismissed Sibal's assertion that there was complete support in the IIT council for the

In a statement, the association said the senates should have the final say on the new pattern and can't be overridden by IIT council.

'PILs to be filed in various High Courts within a week,' the statement said adding initiatives would be taken to get them heard by 5 June when central advisory board of education meets here.

While the new format seeks to give weightage to the class XII results under a two-tier format in deciding the merit list, the association underlined that the school marks should act as a cut off and not given any weightage.

IIT alumni to move court against CET

NEW DELHI: The alumni of the Indian Institute of Technology (IIT)-Delhi will move the court against the Union government's decision to hold a common entrance test for admission to undergraduate engineering courses from 2013.

gineering courses from 2013.

The decision was taken at a meeting of the IIT-Delhi Alumni Association here on Friday. The participants expressed fears that the emphasis on weightage to the school board results and the Joint Entrance Examination (Main and Advance), proposed under the new format, would add to the pressure on students rather than reduce it.

Within a week, the alumni will file public interest litigation petitions in various High Courts, so that they could be heard before June 5, when the Central Advisory Board of Education will meet.

The meeting demanded that status quo be maintained till 2014 and said the new system would result in further mushrooming of coaching centres.

The association said it should be allowed full control of the examination and admission and school marks should act as a cut-off and not given any weightage. The new system has also been rejected by the All-India IIT Faculty Federation.

The new system was announced on May 28, after a meeting of the Joint Councils of the IITs, the National Institutes of Technology and the Indian Institutes of Information Technology with the Federation of Faculty of the IITs. Human Resource Development Minister Kapil Sibal chaired the meeting.

The association, representing more than two lakh graduates of 'the IITs, said the government had "no right to impose a common entrance exam on the IITs."

The association and the Faculty Federation sought more time to discuss the implications of the new system and said the IIT Senates should have the final say and their decision could not be overridden by the IIT Council.

The alumni have planned to

meet the Prime Minister.
"HRD Minister Kapil Sibal did not keep his promise, made to different stakeholders, of not going ahead if there is even one dissent, and here 5 out of 7 Senates have given their dissent in writing, but the HRD [Ministry] still went ahead. नई दिल्ली। इंजीनियरिंग की सिंगल प्रवेश परीक्षा के लिए 28 मई को तय नए प्रारूप का विरोध तेज हो गया है। प्रवेश परीक्षा में प्रस्तावित बदलाव का कड़ा विरोध करते हुए आईआईटी के पूर्व छात्र इस पर रोक लगाने के लिए अगले हपते जनहित याचिका दायर करेंगे। यही नहीं मंत्रालय के फैसले खिलाफ जल्द ही एक प्रतिनिधमंडल प्रधानमंत्री से भी मिलकर इसे रोके जाने की मांग करेगा। यह फैसला शुक्रवार को आईआईटी एल्मुनाई एसोसिएशन की दिल्ली में हुई एक बैठक में लिया गया।

एसोसिएशन के अध्यक्ष सोमनाथ भारती की अध्यक्षता में हुई आईआईटी पूर्व छात्रों की बैठक में चर्चा के दौरान यह स्पष्ट रूप से कहा गया है कि सात आईआईटी में से पांच आईआईटी सीनेट प्रवेश परीक्षा में मंत्रालय के प्रस्तावित स्वरूप से सहमत नहीं हैं इसके बावजुद काउंसिल की सहमति से इसे लग करने का फैसला लिया गया है। बैठक में सदस्यों ने कहा कि आईआईटी प्रवेश परीक्षा जेईई के आयोजन में काउंसिल की भूमिका केवल सलाहकार की होती है। परीक्षा में निर्णायक भूमिका सीनेट की होती है फिर भी सीनेट की राय को मंत्रालय द्वारा अनदेखा किया जा रहा है।

UGC lens on foreign institutions

New Delhi: The Universities Grants Commission (UGC) will discuss a regulatory framework to regulate foreign educational institutions in its meeting on Saturday.

The decision to draft laws to regulate foreign universities comes at a time when the Foreign Educational Institutions (Entry and Operations) Bill, 2010, is pending before Parliament. "There was a need to create a framework to regulate universities of dubious reputation. The Commission will be discussing that in its meeting on Saturday," said Prof Ved Prakash, UGC acting chairman.

The Commission will also look at regulations for twinning and joint degree programmes between foreign and Indian educational institutions. Sources said that the HRD ministry had earlier this year asked the UGC to address the issue of fake foreign universities following students' complaints. The Commission had set up a panel under C N Rao to study the issue. The report is also likely to be discussed in the meeting. TNN

Regulatory framework for foreign varsities, not backdoor entry, UGC says

Apropos "Government trying backdoor" entry for foreign universities" (The Hindu, June 1, 2012), the University Crants Commission has been serously engaged in the analysis of the findings of the various reports on foreign education providers operating in the country with regard to the standing of such providers in their respective countries, the nature of programmes offered by them and the degrees awarded, and above all, protection of the interest of students seeking admission to such foreign institutions.

Many foreign educational institutions are operating in the country offering different types of courses and programmes and there is no regulation presently in place to control and curb the operation of such institutions with academic credentials which may not even be satisfy ing in their own country. The UGC is aware that the AICTE Regulation of 2003 are applicable only for technical and management education but not in the other areas of higher educa-tion. The Ministry of Human Resource Development has time and again emphasised the need to put in a regulatory frames for entry and operation of foreign education providers through a UGC Regulation. This need has also been emphasised by various reports of experts/ committees which include the report of the C.N.R. Rao Committee, the Study Report on for-eign educational institutions eign educational institutions (2005) by the National University of Educational Planning and Administration (NUEPA) and the Report prepared by the Association of Indian Universities (AIU) in 2012.

(AIU) in 2012.

The impression given by The Hindu story that the UGC is going to permit foreign educational institutions through a backdoor channel is not true. The objective of the UGC is to formulate a regulatory frame-work which could be put in place on the lines similar to what has been laid down by the AICTE in

The MHRD has been deeply concerned with this situation and has been approaching the UGC to make a detailed analysis of the implications of the operation of such institutions in the

country.
In a February 1, 2012 letter, it requested the UGC to frame Regulations/Guidelines for the purpose of safeguarding the interest of the student community in India. Accordingly, the UGC constituted a Committee under the Charmanship of Prof. P. Rama Rao in March, 2012 to look into the entire issue and make recommendations which could facilitate the formulation of appropriate regulations. The Report of the Rama Rao committee was subjected to further scrutiny through another committee under the chairmanship of Prof. Ramamurthy Naidu. This committee has finalised the regulations which are now to be placed before the Commission for its consideration.

IIM grads prefer interning with Kalam

LUCKNOW: In 2009, a Lucknow lad from the Indian Institute of Management-Ahmedabad (IIM-A), surprised many by deciding to work fulltime with APJ Abdul Kalam after interning with the 80-year-old former President. Three years later, it has become a trend and the number of IIM grads wanting to intern under the former President

prominent multinational companies," Lucknow-bern Srijan Pal Singh, 28, the trendsetter and a 2009 batch pass-out from IIM Ahmedabad, told Hindustan Times on the phone from New Delhi.

In 2010, one IIM-Ahmedabad student interned under Kalam, fdlowed by six IIM-A graduates next year. This year, the recently set up Kalam Foundation, which Srijar looks after, received 36 applications from IIM-A students who showed an interest in interning under the guidance of Kalam.

"We have admitted eight interns, six from IIM-A and

one each from Calcutta and Indore-based IIMs. We would have selected more. But due to space and resource constraints, we have had to limit the numbers," says Singh. Besides managing Kalam Foundation, Singh also interviews and screens interns.

So how does one explain this trend at a time when an entry into IIMs, specially IIM-A, is considered a virtual passport to a cushy, fat salaried job?

Indranil Hansda, an IIM-A grad interning under Kalam, says the 'experience' has been very diverse and enriching.

"I wanted to gain experience in a proper social development organisation, in order to be able to develop and implement initiatives aimed at the social development of the people at my native place later," he said.

Hansda added that "This internship has turned out to be all that I had expected and more. I have had the exposure to implementation of the social initiatives designed by Kalam Foundation which has provided me an understanding of the various issues. I have also received the opportunity to build on these initiatives. Besides, I have met and established networks with many dynamic individuals who are also involved in various independent social initiatives."

The IIM grads feel that compared to a regular corporate internship the major difference has been that under Kalam, they are given complete freedom to build on their ideas.

"Thus, the experience here is much more fulfilling as the effort I have put in during the internship will hopefully help develop our nation," Hansda says.

Srijan adds: "Yes, there is money in the corporate world.

But, that is one world where you can go back to anytime.

The rich experience you gain under Dr Kalam's patronage, the emotional satisfaction that you get when you try and work on solutions with the great man for empowering India is undoubtedly something that you can't have otherwise." Kalam Foundation has launched several initiatives like 'What Can I Give?' and 'Make Your Mother Smile."

During their internship period, the IIM grads are also sent to villages to study rural life, says Srijan, who has been involved with Dr Kalam's Providing Urban Amenities in Rural Areas (PURA) mission. As someone who now regularly moves with Dr Kalam, he says, the stint has been an enlightening one.

"As IIM students, we get to work for MNCs and start using our knowledge for making profits for the company we serve. But my stint taught me that the real satisfaction comes by serving India, finding solutions to brighten the life of the country's impoverished millions. You always have students who are willing to work in the development sector," says Srijan, rated the best all-round student of the 2007-9 batch of IIM-A.

Srijan says people often want to know the reason for his rather unusual career choice. "At IIM Ahmedabad, I got numerous opportunities to meet and interact with people from the corporate world, alumni of the institute and several others. Most of these people I met had that one big dream still unfulfilled -of trying that one thing. But the opportunity cost had become so big for them now that letting go of what they had become was very difficult for them. I was at an advantage. All I had to do was let go of my secure consulting job," he says.

Srijan's parents in Lucknow were still not convinced until Dr Kalam visited them in 2010. "They haven't mentioned it again," says Srijan.
