## Norms to hire foreign faculty for IITs, IIMs may be eased

New Delhi: Roadblocks in hiring foreign faculty on five-year contracts in government institutions like IITs and IIMs could soon be resolved as the home ministry told its HRD counterparts on Monday that it was proposing a Cabinet note to allow work visa to those who earn a minimum of \$15,000 a year.

At present, work visa is given only to those who earn a minimum of \$25,000 a year. This made it difficult for Indian higher educational institutions to hire foreign teachers at the entry level of assistant professor. The minimum salary norm was for all jobs and was not limited to teaching.

While the home ministry's assurance will help solve the problem of hiring foreign teachers to some extent, the HRD ministry is still worried. It wants to shorten the period of clearance from nearly six months to two or even less. The home and foreign ministries had suggested that clearance should be done by a board and could take six months. HRD ministry sources said this would not attract the best teachers.

In the meeting with officials of home and foreign ministries, the HRD ministry proposed that foreign applicants from countries that have been given most favoured nation (MFN) status should not go to the foreign ministry for political clearance. They should be allowed to straightaway apply to the home ministry for security clearance.

Sources said the HRD ministry also proposed that instead of going through clearances at the time of job application, it should be done at the time of granting work visa. "It could bring down the clearance time to eight weeks," a source said.

# Visa process for foreign faculty in IITs made easier

**OPENING DOORS** Move removes major obstacle in hiring overseas teaching talent

NEW DELHI: Foreign academicians who want to teach at the Indian Institutes of Technology (IITs) will no longer require prior clearance for acquiring visas, a condition that has been a major irritant in hiring overseas talent.

The existing regulatory regime calls for prior approvals from both the ministry of external affairs (MEA) and the ministry of home affairs (MHA), resulting in delays of six to 18 months. According to sources, this usually results in the foreign academician turning down the job offer.

"We have agreed that they need not procure prior political clearance, with the exception of a few cases," said a source.

Another major obstacle – an annual income threshold of approximately ₹16 lakh – is also likely to be relaxed, with the ministry mulling over bringing it down to ₹9.10 lakh for issuing work visas.

It was decided at an August meeting of the IIT council,

chaired by human resource development (HRD) minister Prakash Javadekar, that the authorities should identify potential candidates graduating from reputed international universities to work in Indian institutions. "The government wants to liberalise the existing regulatory regime for appointment of foreign faculty members. A few decisions to this effect were taken at a meeting called by the HRD ministry with the MEA and the MHA on Monday," the source said.

A decision was reportedly taken in principle to ease the existing framework for permitting foreign academicians to teach in India, a senior official said. "Once the proposal is approved by the cabinet, foreign faculty members will be incentivised to teach at IITs. They would be paid over the threshold limit." he added.

The IIT council has decided to systematically increase the number of foreign faculty members at IITs in the near future. "It's necessary to bring in necesary diversification of faculty, and cross-fertilisation of ideas," the official said.

## A year on, IIM-Sambalpur toils without full-time faculty

Six new IIMs, announced in Budget 2014-15, started academic sessions last year. The first of a three-part series takes stock of IIM-Sambalpur

Sambalpur (Odisha), 3 October

A year ago, when Amit Abegaonkar from Latur (Maharashtra) walked into the fledgling Indian Institute of Management (IIM), Sambalpur, his experience was barely fulfilling.

Getting into an IIM usually marks high career aspirations and raises the bar on all parameters - from academic rigour to infrastructure to exposure and placements. But despite the coveted IIM tag, the institute in Sambalpur is struggling to deliver on many of these aspects.

As of now, IIM-Sambalpuris GENERATION running on the rented premises of Silicon Institute of Technology, a private engineering concern, at its Sason campus, some 35 km from Sambalpur, an industrial hub in Odisha's hinterland. IIM-Indore is assigned the task of mentoring IIM-Sambalpur.

A narrow, meandering road flanked by farms leads to this IIM with picture sque hills in the backdrop. "Initially, the institute was not up to the

expectations. Even bare minimum infrastructure like seamless internet connectivity was not in place. But I feel IIM-Sambalpur is slowly evolving and coming on its own," said Abegaonkar, a second year student of Post Graduate Programme (PGP).

IIM-Sambalpur, one of the six thirdgeneration IIMs along with Visakhapatnam, Bodhgaya, Sirmaur, Nagpur and Amritsar, was set up as per the announcement made in Budget 2014-15 to keep pace with the growing demand for good managers. Sambalpur (with no air connectivity), however, was not the initial choice of the Union Human Resource Development Ministry, which chose Bhubaneswar as the location for IIM in Odisha.

IIMs According to sources, the state government's choice for Sambalpur stemmed from political reasons. The state government said a neglected region in western Odisha was selected for the premier institute because it didn't want Bhubaneswar to become base of all important institutions. Turn to Page 16

# A year on, IIM-Sambalpur toils...

For IIM-Sambalpur, the lacuna is not limited to infrastructure alone. Even to this date, the institute is operating without a fulltime director and does not have full-time faculty. "As of now, we have only visiting faculty but they are enough to cater to the academic rigour. The faculty is highly qualified and drawn mostly from IIM-Indore and other IIMs. We are also organising guest lectures where people from noted corporate houses deliver talks," said a student.

Management guru Biswajeet Pattanavak, who has taught at IIMs (Lucknow and Indore), said "To begin with, handholding approach is fine but if it continues for long, it is not in the interest of the students. Having a pool of fulltime faculty is essential for holistic development of the new IIM. Management education is not just academics. It's also about grooming that goes beyond classroom teaching.

Pattanayak said there was wide disparity between the established IIMs and the newer ones on areas

such as quality, exposure, co-curricular activities and holistic development."In my opinion, the new IIMs are finding it difficult to grow without any legacy. Industry connect is very important and this is normally done by a full-time director with his team of faculty, which, in turn, helps students to bag prized placements," said Pattanayak, founder director at School of Asian Business Management (ASBM) with campuses in Hyderabad and Bhubaneswar. "A person with an IIM background can be appointed as full-time director so that he can inculcate here the unique culture of IIMs.

IIM Sambalpur authorities are upbeat on the appointment of a dedicated director. "A full-time director is expected by end of this year. Then, the appointment of full-time faculty will take off. At present, we are focusing on academics. Add-ons like academic and industry collaborations will begin in due course," said Amrut Phalguni Mohanty, officer, IIM-S.

The heartening part is that the

institute has a pool of talented students geared up for critical management roles, said a member of the visiting faculty. "Having been associated with IIM-Sambalpur since its inception, I have observed the students and the college evolve wonderfully. The students here have developed exceptional abilities which enable them to distinguish themselves in the industry. I believe they possess the right mix of attitude and skills to excel," said Rohit Kapoor, professor (operations management & quantitative techniques), IIM-Indore.

For the permanent campus, 237-acre land has been identified by the Odisha government at Basantpur on the outskirts of Sambalpur. Construction is yet to commence and it may take three to four years for IIM-Sambalpur to get a building of its own.

As of now, the institute functions from a rented floor with three active classrooms. Students have access to library which is stocked with the latest journals and books. More than 40 visiting

faculty have been involved in classroom teaching. The maiden batch of PGP took off in 2015-16 with 48 students. "Initially, there were some hiccups but no student was transferred to any other IIM. The first batch has completed four terms in the course and the entire batch has secured 100 per cent summer placement," Mohanty said.

For summer placements, the IIM had 65 offers from 30 companies with ₹70,000 being the highest offer for the two-month period. However, not many recruiters are coming here because of the remote location. It means the placement cell run by the students has to go the extra mile to invite recruiters. For instance, most of the summer placements were sealed through interviews via video conferencing. The second batch of IIM-Sambalpur has been inducted with 46 students and their summer placement concerns have already kicked off the exercise for final placements of the maiden batch.

## HTBombay's intellectual property rules similar to that of MIT

MUMBAI: The Indian Institute of Technology Bombay (IITB) is known to have budding designers and innovators who have time and again proved their genius by coming up with novel products and product ideas. Keeping this in mind, the institute's inhouse magazine, Insight, has analysed the newly upgraded version of IITB's Intellectual Property Rights (IPR) policy. In the article, the rules have been compared to the IPR policy at other universities, including other IITs as well as the Massachusetts Institute of Technology (MIT). One of the main rules is that any IP produced by IITB personnel (student/ staff/research scholars/postdoctoral fellows) will be owned by the institute. "After putting the better half of one's academic time on inventing something that can generate revenue for them, students shouldn't think that the rule is unfair," said Tejas Srinivasan of Insight. While the IP policy is similar across IITs and MIT, royalty sharing models have differed, said students. In IITB and IITKanpur, the share depends on the revenue generated on the IP. One thing common in these institutes is that the copyright on a thesis is solely given to the author. Revenues earned will be shared with the inventor in a 70:30 ratio. "The policy has been designed keeping in mind the rules and regulations followed by other top universities," said a student. The article has also got views of some former students. "In terms of royalty charges, revenue distribution and exclusive licensing, the policy is student friendly. Filing a patent can be expensive and time consuming," said Ashray Malhotra, an IITB alumnus.

## SBI signs MoU with IIT- Kharagpur for research and running proof of concepts

State Bank of India (SBI) has signed a memorandum of understanding (MoU) with IIT Kharagpur for collaborative research and running proof of concepts. SBI has a wider programme includes ideation, incubation, experimentation and commercialization of new technology driven products and services for the banking sector.

IIT Bombay has a similar MoU with SBI and had signed in July. Both parties will identify FinTech start-ups that have products or applications that cater to the financial sector. The bank will provide a platform for testing and piloting such products and check for any specific business linkages. Additionally, the lender said that it may invest in the startups and IIT Bombay's Society for Innovation and Entrepreneurship (SINE) will help in initial screening for technical competency, product road map and innovation subject.

# Submission of MPhil and PhD Dissertation to INFLIBNET Online Depository made Mandatory by UGC

The University Grants Commission of India (UGC) has made it mandatory for universities and colleges across the country to submit an electronic copy of MPhil dissertation and PhD thesis of their students with the online depository named Information and Library Network Centre (INFLIBNET).

Once the dissertations and thesis are submitted to the INFLIBNET the same would be available and accessible for all the institutions or colleges in the country.

In the year 1991 INFLIBNET was set up at the campus of Gujarat University by the UGC and it is basically an autonomous inter-university centre. The objective with which the centre was set up in 1991 was to use the virtual network of people and resources in academic institutions to enable effective and efficient access to knowledge.

The officials of the UGC also expect that in the near future the INFLIBNET would also emerge as a source of revenue through the creation of robust network of virtual library by connecting all institutions providing a seamless, reliable and ubiquitous access to scholarly, peer-reviewed electronic resources to the academic community.
